The extension of the relationship will allow flykk® branded debit Mastercards to be linked to our electronic money services, providing ATM and point of sale access for flykk® members.

The MoneySend agreement will further allow funds to be sent to any Mastercard globally from a flykk® account, providing flykk® members a means to remit funds conveniently, quickly, and cost effectively.

The Mastercard card acquiring service will complement flykk® and ISXPAY® offerings to merchants in UK and will allow ISXPAY® to provide Mastercard acquiring (authorisation and settlement) services to merchants directly.

The Company is planning to rollout card Issuing and Moneysend during 2021.

Materiality of the UK and Australian agreements cannot be assessed at this point in time, pending final rollouts.
